

On March 18, 2014, ANDRITZ AG was informed that FMR LLC (Fidelity Management & Research), an American corporation whose business address is c/o Fidelity Investments, 245 Summer Street, Boston, Massachusetts 02210, United States and its direct and indirect subsidiaries hold approximately 4.45% of ANDRITZ AG shares. Its stake fell below the 5% threshold on March 14, 2014. FMR LLC now holds 4,628,686 shares of ANDRITZ
